# Vendor files complaint against BJP leader Kirit Somaiya, says 'he pushed us'

A street vendor in Mumbai has filed a case against Bharatiya Janata Party (BJP) leader Kirit Somaiya, accusing him of manhandling and collecting penalty money. According to the street vendor, the BJP leader pushed them as he asked them to vacate the place where they were holding their business.He (Kirit Somaiya) came at 8 pm and asked us to vacate the place. When he came again, we told him we are vacating but he pushed us," the vendor told news agency ANI.

He further said that Somaiya even threw the bag of a woman who was buying vegetables. The vendor also alleged that the BJP leader made all of them pay a fine of Rs 1250.

# Dalit man beaten to death in Gujarat's Rajkot on suspicion of theft

Gujarat A Dalit man was allegedly beaten to death on suspicion of death at a factory in Rajkot in Gujarat. The incident occurred on Sunday morning and video of the incident has been shared by many on social media platforms.

Sharing a video of the incident, Gujarat Pradesh Congress Committee president Amit Chavda said that the name of the man beaten to death was Mukesh Vaniya, and that he used to collect garbage from the factory where is was beaten up mercilessly.According to the Congress leader, the wife of the deceased was also beaten up by unidentified men in the factory premises.Allahabad Mirror reported that the man was beaten up by three workers of the same factory. Following this, the police registered a case and detained two suspects for questioning on Sunday.

The complaint was filed by the wife of the deceased, Jaya, said the report. It further said that the factory workers stopped beating up her husband only after she rushed to the spot with some of her relatives.

However, as they rushed Vaniya to the Rajkot Civil Hospital, he succumbed to his injuries. The police have not given any confirmation on the theft charges against the deceased.

A case has been registered by the police under section 302 of the Indian Penal Code.
